COMPLETION OF SHARE PLACEMENT

We advise that settlement of the second tranche of the share placement announced by Red 5 Limited (Company) on 9 September 2013 has been completed. The Company has issued 479,700,000 ordinary fully paid shares at a subscription price of 10 cents each to institutional and professional investors through Petra Capital Limited as lead manager, for gross proceeds of \$47.97 million.
