COMPLETION OF SHARE PLACEMENT

We advise that settlement of the second tranche of the share placement announced by Red 5 Limited (Company) on 14 October 2010 has been completed. The Company has issued 198,000,000 ordinary fully paid shares at a subscription price of 17 cents each to institutional and professional investors through Casimir Capital LP, Petra Capital Pty Ltd and Southern Cross Equities Limited, for gross proceeds of \$33.66 million.

The placement was approved by shareholders at the annual general meeting held on 23 November 2010.

In accordance with ASX Listing Rule 3.10.5, please find enclosed an Appendix 3B in relation to the second tranche of the share placement.
