#### **APPENDIX 2A – VESTING OF PERFORMANCE RIGHTS**

Red 5 Limited (**Red 5** or **the Company**) advises that, in accordance with the terms of the Red 5 Rights Plan (**Plan**), a total of 10,991,282 performance rights (**Performance Rights**) that were issued to key management personnel, senior management and operating personnel in 2018 have vested following the partial achievement of performance conditions measured over the three years ended 30 June 2020.

Upon vesting, 10,991,282 Performance Rights have been exercised into an equivalent number of ordinary fully paid shares in accordance with the terms of the Plan. The balance of 7,327,519 Performance Rights lapsed unvested due to performance conditions not being met.
